Safety Cage Registration Form

Each vehicle that is required to be fitted with a safety cage must have the Safety Cage Registered by CAMS as compliant with the CAMS Manual or otherwise issued with a relevant, CAMS approved Safety Cage Certificate. If the safety cage has not been registered or is not issued with a CAMS approved cage certificate, then this must be included with the CAMS Log Book Application.

A Safety Cage may be registered/certified prior to a CAMS Log Book application.

Vehicle Photograph Requirements

Vehicle photographs MUST comply with the following requirements in order to be approved:

- Digital format full colour, focus, resolution and of a professional quality (1MB or larger)
- Must be in COMPLETE race condition/competition ready (no missing parts or components)
- Must be devoid of additional objects in the background (such as workshop equipment) and must be only of the vehicle itself
