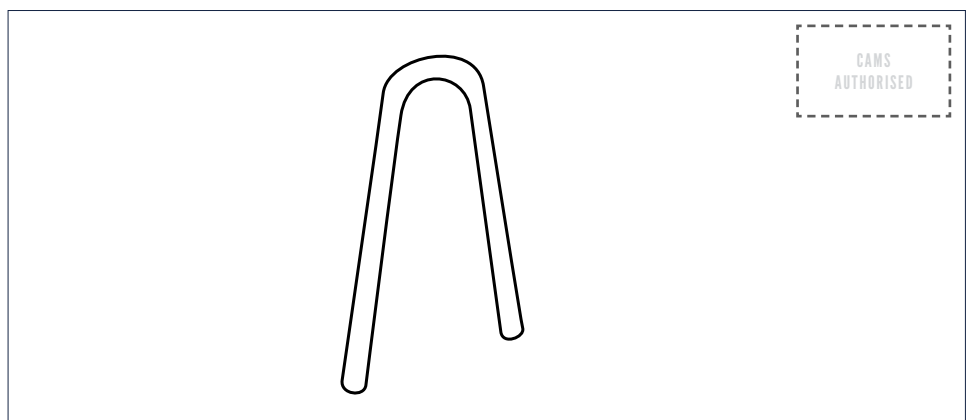

Instructions to Safety Cage Manufacturers and Vehicle Owners

SAFETY CAGE STRUCTURE PICTURES MUST BE SUPPLIED WITH APPLICATION

Safety Cage Registration can be completed once the Safety Cage is installed and prior to a Log Book application.

Note 1: It is the responsibility of the Manufacturer to:

- Read and understand Schedule J of the CAMS Manual of Motor Sport prior to the fabrication of a Safety Cage Structure
- Ensure the accuracy of the information supplied to CAMS

Note 2: Do not use this form with Certified or Homologated Safety Cage Structures.

Note 3: The issue of this document does not signify that the structure has been accepted by CAMS as being in compliance with the requirements for safety cages as specified in Schedule J of the CAMS Manual of Motor Sport, or the relevant Group Technical Regulations.

Note 4: The use of ERW pipe (to AS 1163), which is not drawn to size by a Cold Finishing Process, is not permitted unless the Safety Cage is Certified by CAMS with an Engineers certification. External dimensions of 42.4mm or 48.3mm normally indicate that the tube is ERW, a Cold Formed, not a Cold Drawn or Finished tube.

Note 5: Chrome Moly is not permitted unless the Safety Cage Structure is Certified by CAMS.

Note 6: If this document is submitted to CAMS without a log book application a postal address must be provided in order for CAMS to return the original document and safety cage structure sticker to the customer/ manufacturer.

Note 7: If this safety cage structure is installed in a vehicle which has been log booked by CAMS, the log book is required to be sent to CAMS along with this document for the appropriate amendments to be filled in by a CAMS Officer.

Tube Type: The tubing type is to be shown as one of the following:

- CDS - Cold Drawn Seamless
- CDW - Cold Drawn Welded
- CEW - Cold Drawn Electric Resistance welded.

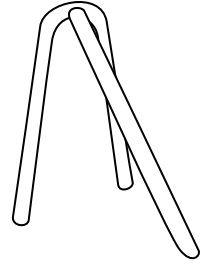
These descriptions are shown on the Product Sheet which should be obtained from your steel supplier with each batch of tubing you purchase.

Dimensions: These sizes refer to the external diameter of the tube and the wall thickness. They will normally be 44.45mm OD for the main hoop and 38mm OD for all other braces, with wall thickness of 2.5mm or greater. This detail is also shown on the Product Sheet for the tubing.

Drawings: Specify the Type and the highest level of competition applied for.

Using a ruler, show the position of the diagonal(s) and any other additional tubes fitted to the Safety Cage Structure.

Supply actual pictures of front and rear aspects of structure (see examples right).
